I. Call to Order

Chair White called the meeting to order at 7:02 p.m. and thanked Capitol Region WD for providing the meeting space. A meeting secretary was assigned: Anna Eleria

A. Attendance, Introductions & Approval of the Agenda

Attendees introduced themselves around the room.

II. Action Items

A. Approve January 17, 2023 Meeting Notes

III. Special Reports and Presentations

James Wisker, Administrator with the Minnehaha Creek WD presented on the District's Climate Action Framework

Purpose of the framework:

Define MCWD's role in field of climate change to bring clarity of focus and scope Identify near term actions and resources needed which impacts funding and staffing Communicate clearly to drive partnerships

Set the stage for policy engagement and midterm planning

5-year planning context and set a road map for 2027 Watershed Management Plan

Reflect unique context of MCWD from geographic, landscape, political

Do not want to be climate gurus – add climate as a lens for their work and ensure it does not take away from integrated planning and partnerships

Started with discovery and framing work
Climate science - prepared the MCWD CAC Climate Action Series Report
Governance scan of existing climate plans and initiatives
Issues and opportunities - SWOT analysis conducted
Reviewed MCWD capabilities
Strategy framing – The most significant connection to MCWD is the flooding threat

Climate Action Framework is defined by three pillars.

Pillar 1 – Understand and Predict – data collection to predict vulnerabilities and risks

Pillar 2 – Convene & Plan – Collaborate and develop a coordinated project and policy strategy

Pillar 3 – Implement, Measure, and Adapt

Today, MCWD is implementing Pillar 1 with three priorities including real-time water level monitoring, flood forecasting, and vulnerability and scenario planning.

Pillar 2 – learning the challenges of partners, use watershed model and address issues

Pillar 3 – deliver high impact projects that build resilience, shape policies

Discussion and questions followed:

Question: How does the MCWD determine their level of involvement in climate action projects? Response: Grid level projects that do not provide regional benefits or have stacked benefits are municipal projects and not MCWD. Navigating through these questions with regulatory lens

Question: Besides Gray's Bay Dam, what other conveyance systems does MCWD own?

Response: Some ditches only

Question: How is MCWD engaging the different City departments at the same time so they are hearing the same message?

Response: Its challenging but it's a requirement for success so they are speaking with TAC members

who are the brokers but are not the decision makers.

Question: Where is the money coming from for this work?

Response: Good question. Looking for proxies like Hennepin County

MCWD is creating a flood response plan so they can rapidly communicate information. Messaging of Gray's Dam was easy because of the flooding. The challenging part is inefficiency of communication with agencies and communication with residents in upper watershed who are located in low lying areas or poorly draining soils.

 - 5 Watershed Management Plans recently approved.
 - April 26th BWSR Board meeting packet available online
 - FY24-25 WBIF preparation will not change the boundaries for allocation areas; intent to make the process easier
 - BWSR Board tour in the South Metro Vermillion WMO
 - 1W1P Implementation tracking discussions takeaway was identification of tracking standards
 - BWSR Academy planning met with local partners to plan this year's academy 9 tracks
- C. MPCA Updates Melissa Lewis
 - a. Environmental bill has passed in the House, which is the source of resiliency grants.
 - b. Federal infrastructure bill will also include resiliency funding.
 - c. Volunteer monitoring program is celebrating its 50 year anniversary.

- E. MDH Updates, Dereck Ritcher
 - a. American Water Association Drinking Water Conference Focus on climate change
 - b. New hydrologist in metro area
 - c. Suggest reaching out to public water agencies about grant funding that is not typical
 - d. MDH has grants specifically for drinking water facilities but there may be connection to WD/WMO work.
 - e. DNR has interactive watershed webpage which includes precipitation.

 - a. Senate accepted the Council's recommendation for \$315M for biennium
 - b. Clean Water Fund is up for renewal in 2030 needs to be reauthorized

 - a. Tina gave an update provided by email
- K. MAWA (Minnesota Association of Watershed Administrators) Update, Tina Carstens
 - a. Executive Committee is working with BWSR leadership on training opportunities through BWSR academy and working on a questionnaire for administrators across the state.

V. Updates from Watersheds

Grace Butler, NMCWD: Salt limited liability legislation did not pass. Lack of agreement and timeline was too fast. Need to work together and get trained on how to advocate effectively.

Jill Crafton (via email) announced a local ecology solutions event at Barr Engineering on April 26th.

John Waller, RCWD: Need a metro version of the lobbying effort by Red River Valley WD. Others support this idea. We need a Metro wide (regional) platform and approach for passing metro watershed legislation.

Additional discussion: Need to find common denominator for metro watersheds. Need better training on advocacy in order to be ready for the next legislative session. Might not need lobbyist, just better trained managers. There are different needs for different parts of the state that require different approaches.

Grace Butler, NMCWD: Would like a future meeting topic on carp issues including policies and protocols as it's a complicated issue.
